## **STAGE 3 DROUGHT RESTRICTIONS**

### **DROUGHT CONTINGENCY PLAN**

BECAUSE CURRENT COMBINED LAKE LEVELS ARE ABOVE 20%, WE ARE NOW IN STAGE 3 DROUGHT RESTRICTIONS UNTIL FURTHER NOTICE.

**IF YOU ARE FOUND VIOLATING THESE RESTRICTIONS YOU COULD BE FINED UP TO \$500.00.**

RESTRICTIONS ARE AS FOLLOWS:

1. **IRRIGATION OF LANDSCAPED AREAS SHALL BE PROHIBITED AT ALL TIMES.**
2. USE OF WATER TO WASH ANY MOTOR VEHICLE, MOTORBIKE, BOAT, TRAILER, OR OTHER VEHICLE NOT OCCURRING ON THE PREMISES OF A COMMERCIAL CAR WASH STATIONS AND NOT IN THE IMMEDIATE INTEREST OF PUBLIC HEALTH, SAFETY AND WELFARE IS **PROHIBITED..**
3. THE FILLING, REFILLING, OR ADDING OF WATER TO SWIMMING POOLS, WADING POOLS AND JACUZZI-TYPE POOLS AND WATER PARKS (UNLESS NON-CITY, ALTERNATIVE SOURCE) IS **PROHIBITED.**
4. ORNAMENTAL PONDS, FOUNTAINS AND WATERFALLS – **PROHIBITED** EXCEPT WHERE NECESSARY TO SUPPORT AQUATIC LIFE.
5. GOLF COURSE IRRIGATION – LIMITED TO ONCE A WEEK ON DESIGNATED WATERING DAY (MONDAY).
6. WASHING BUILDINGS, SIDEWALKS, ETC. – **PROHIBITED**, EXCEPT FOR BUSINESS PURPOSES OR IF IN THE INTEREST OF PUBLIC HEALTH.
7. DUST CONTROL – BY PERMIT ONLY.
8. FOUNDATIONS – LIMITED TO ONCE A WEEK ON THE DESIGNATED STAGE #2 WATERING DAY; ONLY ALLOWED WITH HAND-HELD HOSE OR DRIP IRRIGATION.

**THESE RESTRICTIONS ARE IN EFFECT UNTIL FURTHER NOTICE AND WILL BE ENFORCED.**

NOTE: FOR EVERY DROP OF WATER THAT IS USED ON YOUR LAWNS, WATER LOST DUE TO FAULTY PLUMBING, ETC., IS LESS WATER THAT WILL BE AVAILABLE IN THE VERY NEAR FUTURE FOR DRINKING, BATHING, COOKING, ETC. SO PLEASE HELP CONSERVE OUR WATER SUPPLY.
